To The Honourable Tom Christensen;

The First Nations Child and Family Services Directors Forum (the Forum), which represents 156 First Nations and the Nisga'a Lisims Government communities, have reviewed the drafting instructions of the Aboriginal Authorities Act. Consequently, by formal resolution, the Forum strongly rejects the drafting instructions for the Aboriginal Authorities Act and opposes the regionalization process. The Nations that we represent have an inherent right to care for their own children and families; and this proposed legislation clearly negates that fundamental right.

The failure of the Regional Aboriginal Planning Committees and Interim Authorities to engage in meaningful consultation with our communities, and the misrepresentation of the involvement of the First Nations Delegated Agency Directors has grievously flawed the consultation process. Therefore, the Forum strongly requests a public inquiry into the process to date. The Forum also hereby requests a meeting with yourself and the Leadership Council, to provide a formal opportunity to voice our position and specific concerns.

Further, as the Forum provides technical advice regarding child and family services to our respective governance structures, this letter will be brought to the immediate attention of the Chiefs we represent.




